Customers are becoming a member of the club based on their free will they express with their signature on the application form or other according to the law applicable way of will.

Membership in the Květinový klub

Every physical entity older than 16 years with correspondence address at the Czech Republic, who agrees with the general conditions, can become a member of the Květinový klub. Body corporate cannot become a member of the Květinový klub. Membership is complimentary. Every customers of the Květinový klub are entitled to become members, after fulfilling club application and agree with the general conditions of the discount programme. Members activate their club cards on the web page www.kvetinovyklub.cz, where they fill in every requested detail. Activation of the club card is done by Květinový klub when registering at one of our shops.

1. Use of the club cards

1.1. Club cards can be used in all shops of Květinový klub:

Květinový klub, Komunardů 47B, Praha 7

2. Discounts and their usage

- 2.1. Appropriate discount will be referred to each member when submitting the club card. No discounts are offered, when member does not submit the club card.
- 2.2. Discounts offered by the membership of the Květinový klub cannot be applicable to already discounted goods. Discounts are not cumulative.
- 2.3. Members' club card cannot be used for purchase of the Gift Vouchers of Květinový klub. Members' club card can be used when paying with the Gift Vouchers of the Květinový klub; however the final amount of the purchase inclusive of the discount has to be higher than the value of the Gift Voucher.

3. Communication with the members of the Květinový klub

- 3.1. Communication with the Květinový klub members is via emails (klub@kvetinovyklub.cz) and SMS (+420 774 44 66 22 or +420 774 44 66 20) to the e-mail address and telephone numbers, filled in the application form by the members. Květinový klub has the right to inform its members about:
 - 3.1.1. special events of the Květinový klub
 - 3.1.2. news and seasonal tips
 - 3.1.3. floristic and arranging courses
 - 3.1.4. new shops, opening hours and others

4. **Sign-off the Květinový klub**

- 4.1. Every member of the Květinový klub can sign-off when filling up sign-off form; available on the web pages www.kvetinovyklub.cz. Sign-off form and the club card will be sent to the seat of the company Květinový klub, Sixth Sense s.r.o., Na Balkáně 2120/134, Praha 3, 130 00. Members lose the right for the discounts in Květinový klub when sign-off.
- 4.2. All personal information about club members will be irrevocably deleted from the club database.
- 4.3. Květinový klub has the right to sign-off a member, who filled in the application form meaningfully incorrect details, personal details and telephone or email details.

5. **General conditions and Protection of the personal information**

- 5.1. Member of the club agrees, that will be regularly informed via SMS or email about the club activities. Members confirm with the signature on the application form correct contact details and are informed about the Květinový klub declaration of protection of the personal information. Members confer upon signing the application form their approval that Sixth Sense s.r.o. will process personal information in accordance with the Czech code of law 101/2000 about the protection of the personal information, for indeterminate time period, until call back of the approval or until the end of the club functioning.
- 5.2. Club members are acknowledged that they can call back their approval anytime in writing and Sixth Sense s.r.o. will liquidate this information. Sixth Sense s.r.o. as a administrator process the personal information in accordance with the Czech code of law 101/2000 about the protection of the personal information, registered by the club member and for the purpose of services offers and for the purpose sequent on the general conditions of the Květinový klub. Administrator has the right to process the personal information by means of the processors. Květinový klub members are acknowledged that designated processors do not underlie to another approval.
